Orting is a family-friendly bedroom community located in the foothills about an hour south of Seattle. Orting is known for its semi-rural setting, quaint downtown, breathtaking views of Mt. The mission of the City is to provide services with integrity, teamwork and initiative to make Orting a better place to live, work, play and do business, while preserving a strong sense of community.



THE COMMUNITY DEVELOPMENT DIRECTOR

Under the general supervision of the City Administrator, the Community Development Director integrates the Planning, Building and Code Compliance operations of the Community Development Department. The Community Development Director plans, organizes, directs and controls the functions of the Department, which include current planning, long-range planning, code enforcement, building and fire plan review, inspections and permitting. The Department operates with a team of 2.75 FTEs.

The Director advises the Mayor and City Council by making policy recommendations on various land use and development issues. This position requires a high degree of subject matter expertise, independent judgement, initiative, and discretion.
